- to fill in forms when entering university residences and, if necessary, to be subject to body temperature control and momentarily isolated in the event of a temperature above 37.5° and, as soon as possible, to contact your doctor, the health care company at 800 867 388 and follow the instructions provided by Opera Universitaria;
- to measure body temperature on a daily basis in order to monitor any covid symptoms
- that if fever (over 37.5°) or other flu symptoms appear after entering the facility, you will be obliged to stay at home, to contact the health company immediately on 800 867 388 and to inform the Opera Universitaria by calling 0461/217490- 0461/217403. The Opera Universitaria, on the basis of the dispositions of the competent Health Authority, will proceed with the isolation of the student and of the other subjects present in the premises;
- to behave in any other way that is necessary and useful for the health of individuals and common safety;
- to share the common areas inside the facilities.
