## **1. RECIPIENTS**

This call for applications is intended for students who are less than 35 years old on January 1<sup>st</sup> 2025, who are citizens of European Union countries, Iceland, Norway, Liechtenstein, San Marino, Switzerland, and Vatican City and for students who are resident in Italy but are citizens of non-EU countries:

- who enroll at the University of Trento for the first year or subsequent years in the following courses:
  - Undergraduate degrees
  - Master's degrees
  - Five- and six-year Master's degrees
  - PhD programs, who are not benefiting from other scholarships or other kinds of funds for the PhD program, nor have been regranted a paid leave of absence
- who enroll at the Conservatory of Music or another University Institute of Trento for the first year or subsequent years for the following courses:
  - Undergraduate degree from the Advanced School for Linguistic Mediators in Trento (SSML) and from the "Trentino Art Academy" Advanced Art Institute and undergraduate degree from the Conservatory of Music of Trento "F.A. Bonporti"
  - Master's degree from the Conservatory of Music of Trento "F.A. Bonporti"
- who intend to transfer to the University of Trento, the Conservatory or a University Institute of Trento from another University or Institute.

In case of simultaneous enrolment for a.y. 2025-2026 in two courses of study, those who are already enrolled in a course of study in years subsequent to the first, and who have already taken advantage of the benefits for the right to study, cannot consider the second enrolment as the reference for the purpose of obtaining the same benefits. Only if they have not already taken advantage of the benefits for the right to study, students can request the aforementioned benefits (which they have never requested) for their second course of study.

#### NOTE

The application for benefits must be submitted regardless of the actual enrollment for the a.y. 2025-2026 for which different deadlines may be envisaged falling after the deadline for submission of this application, including if the student does not know the results of the admission test or has not yet enrolled in the course for which he/she is submitting the application for benefits (for example, a student who is not yet enrolled



in a Master's degree program on 8th September 2025 must still submit the application for benefits within the deadlines set out in paragraph 10.2 of this call).

#### SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

Students enrolling for the "filter semester" at the University of Trento, according to the provisions of Legislative Decree no. 71/2025, must submit the application for benefits by the deadlines indicated in paragraph 10.2.

For those who will enroll in the "filter semester" at another university and then matriculate in Trento in the second semester, different deadlines may be established in light of the implementing decrees to be adopted by the Ministry. In this regard, an addendum to the call will likely be approved by the end of July, and will be appropriately publicized on the institution's website.

## 2. STUDENT AID

The income and merit-based benefits available for "capable and worthy students regardless of their financial condition" (art.34 of the Constitution) are the following:

- Scholarship
- **accommodation** in collective residences and flats
- exemption from the **provincial student welfare tax**
- total exemption from university **<u>tuition fees</u>**.

Students of the Advanced School for Linguistic Mediators in Trento and the *Trentino Art Academy* Advanced Art Institute are not eligible for the total exemption from university <u>tuition fees</u>.

#### SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

Following the approval of the implementing ministerial decrees, the call for applications will be amended, likely by the end of July, in order to establish the terms for accessing benefits for the students concerned, and to set a different deadline for those who, after completing the "filter semester" at another university, will enroll in the Medicine and Surgery degree program at the University of Trento. This addendum will likely be



approved by the end of July and will be appropriately publicized on the institution's website.

## **3. REQUIREMENTS**

#### **3.1.FINANCIAL CONDITION**

According to the Resolution by Provincial Council no. 808 dated June 6<sup>th</sup> 2025, the financial situation will be defined based on **ISEE** 2025 (Equivalent Financial Situation Indicator) issued for **university** education benefits and <u>ISPE</u> (Equivalent Asset Indicator).

The limit of the <u>ISEE</u> for university education benefits for a student to qualify for the benefits is € 26.000,00 and € 52.000,00 for the <u>ISPE</u>.

Students must meet the two limits (ISEE and ISPE) jointly: if just one of the two limit exceeds, the student does not satisfy the financial requirement and is not eligible for the benefit.

#### **3.2.MERIT**

Merit is based on the number of <u>credits</u> earned and recorded by the relevant Offices in relation to the year of first enrolment (for clarifications about the meaning of "<u>year of first enrolment</u>" please carefully read the corresponding entry in the glossary). When calculating merit, Opera Universitaria will not consider any <u>credits</u> awarded for competencies acquired prior to enrolment (CPA and CMPA).

#### **3.2.1.YEARS FOLLOWING THE FIRST**

Students enrolled in years subsequent to the first must fulfill a merit requirement based on the number of <u>credits</u> earned and registered **by August 5<sup>th</sup> 2025 (by 30th September 2025 for students of the Conservatory, the part-time degree course in Business Management, the master's degree courses in Civil Engineering, and Environmental and Land Engineering, European and International Studies and the six year Master's degree course in Medicine and Surgery**), starting from the <u>year of first</u> <u>enrolment</u>. <u>Tables 1</u> and 2 in the Appendix show the minimum merit requirement for accessing the benefits with reference to the <u>year of first enrolment</u>.

For students with disabilities, please refer to point 8.

#### 3.2.2.BONUS

To reach the minimum merit requirement referred to in <u>tables 1</u> and  $\underline{2}$  in the Appendix, in addition to the earned <u>credits</u>, the



student can also use a bonus of up to a maximum of five (5) credits during the entire course of the university careers.

If the bonus credits have not been used during the current academic year, they can be used during the following years. If the students have already used the bonuses in previous years to request the benefits (including during a three-year degree programme either at Trento University or at another University or University Institute) they will have a number of bonus creditsgiven by the difference between the maximum 5 credits available and the credits already employed.

**Example**: a student enrolled for the a.y. 2024-2025 in the Economics and Management degree programme (40 credits <sup>G</sup> required), has earned 36 credits <sup>G</sup> by August 05<sup>th</sup> 2025: to get the scholarship, the student uses 4 bonus credits and will only have 1 credit left to be used in the following years to reach the minimum merit requirement.

#### 3.2.3.STUDENTS TRANSFERRING TO A DIFFERENT DEGREE PROGRAM WITHIN THE UNIVERSITY OF TRENTO

Students transferring to a different degree program within the University of Trento must meet the merit requirements of the new degree program referring to the year of first enrolment (as per <u>Tables 1</u> and <u>2</u> in the Appendix); <u>credits</u> obtained and recorded in the student's career by **5<sup>th</sup> August 2025** may be counted in the merit calculation, in relation to the year of first enrolment. Credits not recognized in the new course cannot be used when applying for benefits in subsequent academic years.

**Example**: a student enrolled for the a.y. 2024/2025 in the Business Administration degree programme who, for the AY 2025/2026 transfers to the Economics and Management degree programme, must have earned 40 <u>credits <sup>G</sup></u> by August 5<sup>th</sup> 2025, instead of 35.

#### **3.2.4.STUDENTS TRANSFERRING FROM ANOTHER UNIVERSITY**

Students transferring from other Universities must fulfill a merit requirement based on the number of <u>credits</u> earned and recorded by August 5<sup>th</sup> 2025 at their former University, with reference to the <u>year of first enrolment</u>. <u>Credits</u> not recognized by the University of Trento cannot be used to apply for benefits in the following academic years. <u>Tables 1</u> and <u>2</u> in the Appendix



show the minimum merit requirement for accessing the benefits with reference to the <u>year of first enrolment</u>.

#### **3.2.5. FIRST-YEAR STUDENTS**

All first-year students must meet special merit requirements to obtain the payment of the scholarship, as specified in <u>section</u> 4.2.1.

#### 3.2.6. PHD

Opera Universitaria requires students enrolled in PhD courses to be regularly registered to the a.y. 2025-2026.

## 4. SCHOLARSHIP

#### 4.1.AMOUNT

The scholarship amount varies according to the financial situation of the student's <u>household</u>, the municipality of residence and the applicant's housing status.

Students with an <u>ISEE</u> indicator equal to or less than two-thirds of the threshold value set forth in <u>point 3.1</u>, will be eligible for a scholarship whose maximum amount is determined by the resolution of the Provincial Council no. 808 of 6 June 2025 subject to any adjustments provided by ministerial decree no of February 28<sup>th</sup> 2025.

For students with an <u>ISEE</u> indicator exceeding two thirds of the threshold value and up to the maximum limit, the scholarship is progressively reduced up to half of the maximum amount.

For students with an <u>ISEE</u> indicator less than or equal to half the maximum set limit, the amount of the due grant is increased by 15%.

For female students enrolled in <u>S.T.E.M.</u> courses the amount of the grant is increased by 20% (this is not cumulative with the abovementioned 15%).

For those who, starting from a.y. 2022-2023, are enroled in two courses at the same time, a 20% supplement to the scholarship obtained each year will be granted, provided that they maintain the

merit requirements specified in the Opera Universitaria call for the course for which they receive the scholarship, as well as those outlined in the Ministerial Decree No. 1320/2021 for the second course, for the entire duration of their studies. Opera Universitaria will pay this supplement in relation to the fulfillment of the relative requirements year by year.

The amount of the scholarship for the last semester corresponds to half of the annual scholarship amount.

The increase in the scholarship amounts for the a.y. 2025-2026 are allocated thanks to the additional resources provided by



the PNRR (National Recovery and Resilience Plan), with funding from the European Union - Next Generation EU and investment 1.7 "Scholarships for access to university" of Mission 4 Component 1.

#### 4.1.1.RESIDENT SCHOLARSHIP

The scholarship amount for students residing in "local" municipalities (as listed in Tables 3 and 4 in the Appendix), ranges from a minimum of  $\in$  1,425.13 to a maximum of  $\in$  2,850.26, depending on their financial situation.

#### 4.1.2. SCHOLARSHIP FOR COMMUTING STUDENTS

The scholarship amount for students residing in "commuting" municipalities (as listed in <u>Tables 3</u> and <u>4</u> in the Appendix), ranges from a minimum of  $\in$  2,066.43 to a maximum of  $\in$  4,132.86, depending on their financial situation.

#### 4.1.3. NON-RESIDENT SCHOLARSHIP

The scholarship amount for students who reside in "non-local" municipalities (as listed in <u>Tables 3</u> and <u>4</u> in the Appendix) and who rent accommodation near the course location for at least 10 months during a.y. 2025-2026 (5 months for students applying for the scholarship only for the last semester), ranges from a minimum of  $\in$  3,536.05 to a maximum of  $\in$  7,072.10, depending on their financial situation.

Students who do not live in the facilities provided by Opera Universitaria are required to upload on the ONLINE APPLICATION section of the www.operauni.tn.it from September 9<sup>th</sup> 2025 to October 15<sup>th</sup> 2025, a copy of the **rental agreement**<sup>G</sup> registered in their name (or copy of the accommodation assignment if staying in a collective residence) with a minimum term of 10 months during the a.y. 2025-2026 (between September 2025 and August 2026). Students who, in previous years, delivered a multi-year rental agreement to Opera Universitaria, must provide evidence that the rental agreement is also valid for a.y. 2025-2026 by uploading the supporting documentation to the ONLINE APPLICATION from September 9<sup>th</sup> 2025 to October  $15^{th}$  2025 (see rental agreement). If the student signed a multi-year rental agreement with "cedolare secca" option and he/she has already sent it to Opera Universitaria the previous year, the student, instead of uploading the documentation again, can certify autonomously that he/she still lives there by uploading in the online procedure the form "Contract self-statement" published on the www.operauni.tn.it website in the Scholarship/Forms section.



#### NOTE

For the purpose of awarding the 'off-campus' scholarship, rental contracts submitted after the deadline of October 15<sup>th</sup>, 2025 deadline, will not be considered under any circumstances, except for the cases specified below

Students enrolling after October 15<sup>th</sup> 2025 in a Master's degree or in a PhD program or who will enroll in another degree program as a result of the re-selections made by the University of Trento, may upload the <u>rental agreement</u> (or access facilities provided by Opera Universitaria) by December 31<sup>st</sup> 2025, obtaining a "non-resident" scholarship for a period proportional to the months of actual rental agreement until August 31<sup>st</sup> 2026.

## SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

For students who will enroll in the 'filter semester' as outlined in Legislative Decree No. 71/2025, different deadlines may be set, depending on the implementing decrees to be adopted by the Ministry. Opera Universitaria will approve an addition to the call by the end of July, which will be appropriately publicized on the institution's website.

Students residing in any municipality who pay for accommodation and meet the regulation's requirements to be considered 'independent' are also considered 'not resident'. I.e. this includes having adequate income capacity from employment or similar (at least € 9,000 per year, for at least two years) and who have not been resident, for at least two years from the application date. In their family of origin's accommodation unit or an accommodation owned a family member. These students will have to upload their housing documentation by the deadline of October 15<sup>th</sup> 2025.

Students who, upon reaching the age of majority, live away from their family of origin based on a decision by the judicial authority ("care leavers") and meet the economic and merit requirements specified in this call, are still considered "**nonresident**" students, regardless of their municipality of residence.

"Commuting" students are also:

 residents in "non-resident" municipalities who do not rent accommodation in the proximity of the course location;



- residents in "non-resident" municipalities who rent accommodation in the proximity of the course location and do not upload in the ON LINE APPLICATION a copy of the <u>rental agreement</u> or the "Contract self-statement" form in case of a multi-year rental agreement with "cedolare secca" by the deadline set out in the Call for application;
- students residing in "non-local" municipalities who obtained an accommodation and, for any reason, do not directly pay the housing fee since they have been assigned a free accommodation place or benefit from a rent contribution granted by the University of Trento or another Institution.

For students spending time in Italy or abroad for internships or international mobility programs, for which a financial contribution is provided by Opera Universitaria, by the University of Trento or by another Institution, the "non-resident" scholarship will be disbursed only for the months spent in Trento (as proved by the <u>rental</u> <u>agreement</u>, whereas a "resident" scholarship will be disbursed during the months spent elsewhere, provided that the overall period spent in Trento and in another Institution must be of at least 10 months.

If the student submits a <u>rental agreement</u> of at least 10 months by October 15<sup>th</sup> 2025 and later participates in the Erasmus+ program, they will be required to return part of the non-resident scholarship in the second semester, after the University of Trento confirms the student's actual departure abroad.

Students who take part, in Italy or abroad, in internships, thesis research, or other international mobility programs may retain the full amount of their "non-resident" scholarship if all the following conditions are met:

- the participation to the study project is certified by the University of Trento;
- they do not benefit from any another scholarship, grant or remuneration;
- they must send a copy of the <u>rental agreement</u>, whether respectively in Italy or abroad, provided that the rental period at least 10 months.

For students with disabilities, please refer to point 8.

#### 4.2.DISBURSEMENT

The scholarship will be disbursed to eligible students exclusively by transfer to a current account (or credited to a prepaid card able to receive bank transfers without amount limits) held or jointly held in the student's name. When filling out the application, and in any case no later than October 31<sup>st</sup> 2025, the student must indicate their <u>IBAN</u> code by clicking on "Accedi ai dati anagrafici e bancari".



Otherwise, if due, the scholarship will be credited starting from February 2026.

#### **4.2.1. FIRST-YEAR STUDENTS**

For the total amount of the scholarship to be disbursed, the student must meet a certain merit requirement determined by the number of <u>credits</u> earned and registered by the relevant offices during his/her studies. Any credits awarded for skills acquired prior to enrollment (CPA and CMPA) cannot be considered in the merit calculation.

For students with disabilities, reduced merit requirements may be considered as specified in <u>point 8</u>.

Students enrolled in **bachelor's degree programs or firstlevel diploma courses and single-cycle master's degree programs** will receive **20%** of the total amount of the scholarship by November 10<sup>th</sup> 2025. The **30%** of the total amount of the scholarship will be disbursed by December 2025.

Those enrolling in a master's degree program by October 31<sup>st</sup> 2025 will receive 50% of the total amount of the scholarship within December 2025. Students enrolled in a **master's degree program** after October 31<sup>st</sup> 2025 will receive 50% of the total amount of the scholarship by February 2026.

The remaining 50% of the scholarship total amount will be disbursed upon earning, by 5<sup>th</sup>.August 2026 (by 30<sup>th</sup> September 2026 for students of the Conservatory, part-time Business Administration degree program and Master's degree programs in Civil Engineering, Environmental and Land Engineering, European and International Studies and the single-cycle Master's degree in Medicine and Surgery), the number of <u>credits</u> required for students enrolled in the a.y. 2024/2025 as per <u>Tables 1</u> and <u>2</u> in the Appendix.

First-year students enrolled in new degree programs activated by the University of Trento in the a.y. 2025-2026 are required to earn 35 **credits** by August  $5^{th}$  2026 to reach the merit and to hence receive the remaining 50% of the total amount of the scholarship.

For students with disabilities, please refer to point 8.

#### NOTE

Bonus credits cannot be used to meet the merit requirement for the disbursement of the remaining 50% of the total scholarship amount. The disbursement of this amount will be made automatically, after verifying the achievement of the merit recorded in the student's academic career, starting from March 2026.



## SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

For students who will enroll in the 'filter semester' as outlined in Legislative Decree No. 71/2025, different deadlines may be set, depending on the implementing decrees to be adopted by the Ministry.Opera Universitaria will approve an addition to the call by the end of July.

### **4.2.2. YEARS FOLLOWING THE FIRST**

The scholarship will be paid also according to the timing of disbursement of the additional resources provided as part of the PNRR: in a single installment by the end of December 2025, or in two tranches, with the first disbursed by the end of December 2025. In the case of payment in two installments, and subject to the availability of resources, the full amount may be awarded to beneficiaries with a more disadvantaged economic condition.

#### 4.2.3. PHD

For eligible students enrolled in PhD programs, the scholarship will be paid in a single installment within 60 days of the approval of the ranking list, provided they are regularly enrolled in the a.y. 2025-2026.

## **5. EXEMPTION FROM TUITION FEES**

#### **5.1.UNITRENTO STUDENTS**

Students eligible for a scholarship under this Call for Applicants and beneficiaries of the Ministry of Foreign Affairs scholarship for the a.y. 2025-2026 are entitled to total exemption from <u>tuition fees</u> and <u>provincial student welfare tax</u>. Students who are no longer eligible for a scholarship will be required to pay the University of Trento the fees due for the a.y. 2025-2026, calculated according to the specific <u>ISEE</u> for social security benefits related to the right to university education (locally known as "ISEE Università"), requested as indicated by INPS and the timeline set out in the <u>Tasse Universitarie</u> page on the University website.

#### 5.1.1.NO EXEMPTION

Students who are not eligible for a scholarship and, therefore, do not qualify for exemption, will be required to pay the <u>tuition fees</u>. After the approval of the scholarship eligibility ranking, the amount due will be visible in the personal area <u>Esse3</u> (MyTasse). If the student enrolls after the ranking approval, they must notify the University of Trento that they are not eligible for the tax exemption. <u>Tuition fees</u> for bachelor's degree programs, master's degree programs and single-cycle degree



programs will be calculated based on the compliant version of <u>ISEE<sup>G</sup></u> Università". Details on how to make the <u>ISEE</u> calculation and the relevant payment deadlines are available on the web area <u>Tasse Universitarie</u> on the University website. A late payment penalty will be charged in case of payment beyond the due date indicated on the notice of payment PagoPa.

#### 5.1.2. EXEMPTION FIRST YEAR "FUORI CORSO" (STUDENTS ENROLLED IN THEIR FIRST YEAR AFTER THE NORMAL DURATION OF THE COURSE)

Master's degree and single-cycle Master's degree students eligible for the scholarship, who intend to enroll in the a.y. 2025-2026 for their first year beyond the normal duration of the course (with reference to the <u>year of first enrollment</u> can benefit from **partial** exemption. They will have to pay to the University of Trento, in addition to the stamp duty, an amount equal to half of the tuition fees, which may be reduced based on the compliant University <u>ISEE</u> following the procedures and deadlines indicated on the <u>Tasse Universitarie</u> page on the University website. After the approval of the scholarship eligibility ranking, the amount due will be visible in the <u>personal area Esse3</u> (Mytasse).

A late payment penalty will be charged in case of payment beyond the due date indicated on the notice of payment PagoPa.

#### 5.1.3. EXEMPTION FOR STUDENTS WITH UNDERGRADUATE DEGREES EARNED AFTER SEPTEMBER 8TH 2025, WHO INTEND TO ENROLL IN THE FIRST YEAR OF A MASTER'S DEGREE PROGRAM FROM SEPTEMBER 9TH 2025 UNTIL THE LATEST DEADLINE SET BY EACH DEPARTMENTS/CENTERS

The students who will earn a bachelor's degree after September 8<sup>th</sup> 2025 and who intend to enroll in the first year of a master's degree program at University of Trento from September 9<sup>th</sup> 2025 until the latest deadline set by each Department/Center, must still submit the application for the scholarship by September 8<sup>th</sup> 2025.

In case of non-eligibility for the scholarship when enrolling in a degree program at UniTrento, the student must notify the noneligibility for the scholarship and pay the first installment of the <u>tuition fees</u> and the possible following installments, which are calculated based on the compliant version of ISEE University, as specified on the web page <u>Tasse Universitarie</u> on the University website. All amounts due will be shown in the <u>Esse3</u> (Mytasse) personal web area. In case of payment beyond the due date indicated on the notice of payment PagoPa, a late payment penalty will be charged.



Please refer to <u>point 8</u> for information about exemption for students with disabilities.

#### NOTE

The calculation of the ISEE for University, required for the reduction of the standard enrollment fees at UniTrento for the academic year 2025-2026, must be requested from INPS by submitting the <u>Dichiarazione Sostitutiva Unica <sup>G</sup></u> (DSU) according to the methods and deadlines indicated on the <u>University Fees</u> page of the University's website.

In the absence of the <u>ISEE <sup>G</sup></u> for University, calculated according to the deadlines indicated on the University Fees page for the a.y. 2025-2026, the maximum amount of <u>university fees</u> must be paid.

#### 5.2.CONSERVATORY

Students eligible for a scholarship are entitled to total exemption from <u>university taxes</u> and <u>provincial student welfare tax</u>. Students who lose their eligibility to receive a scholarship during the academic year will have to pay the <u>provincial student welfare tax</u> to Opera Universitaria calculated according to the <u>ISEE G</u>, in the manner that will be communicated to them by the administrative office of the Conservatory of Music.

Students ineligible for the scholarship will have to pay the <u>provincial</u> <u>student welfare tax</u> to Opera Universitaria by November 30<sup>th</sup> 2025, calculated according to the <u>ISEE <sup>G</sup></u> system, as indicated on the website <u>https://conservatorio.tn.it/en/taxes-contributions/</u>.

#### **5.3.SSML, TRENTINO ART ACADEMY AND PHD STUDENTS**

Students eligible for a scholarship are entitled to exemption from the provincial student welfare tax. Students who are not exempt from the provincial student welfare tax must pay  $\in$  150.00 by November 30<sup>th</sup> 2025, according to the procedures that will be notified by SSML or by the Trentino Art Academy or as set out on the University portal for PhD students.

## 6. ACCOMMODATION

Students who meet the financial situation and merit requirements as per point 3 and reside in a "non-local" municipality, are eligible for accommodation at a reduced rate. The "non-local" municipalities of residence are listed in Tables 3 and 4 in the Appendix.

Students who, upon reaching the age of majority, live away from their family of origin based on a decision made by the judicial authority ("care leavers") and meet the economic and merit requirements specified in this



call, can request accommodation at a reduced rate regardless of their place of residence.

#### **6.1. CONFIRMATION OF ACCOMMODATION**

Students who received the scholarship and <u>accommodation</u> for the a.y. 2024-2025 can confirm their accommodation for the a.y. 2025-2026 by **filling in the ONLINE APPLICATION by August 5<sup>th</sup> 2025** provided that they have an active assignment record with Opera Universitaria at the time of application submission and meet, the financial situation requirements in <u>point 3.1</u>, as well as the merit requirements in <u>Tables 1</u> and <u>2</u> in the Appendix.

To confirm the accommodation, the assignment record must expire on August 31<sup>st</sup> 2025 (July 31<sup>st</sup> 2025 for students living in the Barelli accommodation in Rovereto).

Students enrolled in a bachelor's degree program in a.y. 2022-2023, who received the scholarship for a.y. 2024-2025 and wish to confirm their <u>accomodation</u> for a.y. 2025-2026, must have gained and registered at least **140** <u>credits</u> by August 5<sup>th</sup> 2025 (by September **30<sup>th</sup> for students attending a course at the Conservatory**). If a student earns their bachelor's degree by August 5<sup>th</sup> 2025, they can confirm accommodation for the master's degree, provided enrollment happens by the same date (otherwise the student will have to request a new assignment).

#### **6.2.NEW ASSIGNMENTS**

Opera Universitaria has **210 accommodation places in Trento and 20 in Rovereto**, which will be assigned by the first week of September 2025. The <u>accommodation</u> is assigned automatically and on an annual basis. If additional accommodation becomes available, further accommodation assignments may be made.

Students applying for <u>accommodation</u> must indicate in their application for benefits where they intend to live (Trento or Rovereto) and, if eligible for accommodation according to the ranking, they must confirm the acceptance **within 2 days from the date of ranking approval**. Students will receive an e-mail with instructions to accept the <u>accommodation</u> offered. Failure to accept by the deadline indicated will be considered as a waiver.

In case of withdrawals or declined offers, eligible students will be contacted via e-mail according to their ranking order: they will also have **2 days** to confirm the acceptance of the <u>accommodation</u>.

#### NOTE

It is recommended to check your email (both university and personal email addresses) daily during the housing assignment period.



Please refer to point 10.2 for the <u>accommodation</u> application deadlines.

Information for students with disabilities can be found in point 8.

#### 6.3.PAYMENT

The monthly accommodation fees at a reduced rate are as follows:

- double room € 190.00 per month
- single room € 230.00 per month

In addition to the monthly fee, the student is also to pay a noninterest-bearing deposit of  $\in$  360.00 and a check-out cleaning charge of  $\in$  40.00.

The payment methods for the monthly rent and deposit will be communicated jointly with the accommodation assignment.

Accommodation fees are due as follows:

- by 30 November 2025, fee covering until December 2025;
- bimonthly payment, to be settled by the end of the first month of the bimonthly period, for the period from January 2026 until August 2026.

The deposit of  $\in$  360.00 will be refunded at the end of the assignment of the accommodation in the cases and with the modalities set out in the Regulation governing the use of Opera Universitaria accommodation facilities available on the website <u>www.operauni.tn.it</u>, within 60 days after the end date of the assignment.

Payment delays and installments payments are not allowed. In case of non-payment of the due amounts the <u>accommodation</u> will be revoked. Interest and expenses will be charged on overdue amounts and collected according to the ordinary enforcement procedures (credit recovery through Trentino Riscossioni).

## 7. DURATION, EXCLUSION AND REVOCATION OF BENEFITS

#### **7.1.DURATION OF BENEFITS**

The benefits under this Call are awarded as follows:

- for students enrolled in **bachelor's degree programmes**:
  - scholarship and tuition fees exemption (provincial student welfare tax for the Advanced School for Linguistic Mediators SSML and the Trentino Art Academy) for a period corresponding to the standard duration of the respective study programs, starting from the <u>year of first enrolment<sup>G</sup></u>;
  - <u>accommodation</u> for a period corresponding to the standard duration of the study program, plus one year for those who can confirm <u>accommodation</u>



- for students enrolled in master's degree programmes and single-cycle **master's degrees programs**:
  - scholarship and tuition fees exemption for a period corresponding to the standard duration of the study program plus one semester (the amount of scholarship for the last semester is 50% of the annual scholarship), starting from the <u>year of first enrolment<sup>G</sup></u>. The amount for the last semester will not be disbursed if the student graduates by October 31<sup>st</sup> 2025.
  - <u>accommodation</u> for a period corresponding to the standard duration of the study program, plus one year starting from the <u>year of first enrolment</u>
  - for students enrolled in part-time programmes and PhD programmes:
    - scholarship, tuition fees exemption and <u>accommodation</u> for a period corresponding to the standard duration of the study programs, starting from the <u>year of first enrollment</u>

Please refer to <u>point 8</u> for the duration of benefits for students with disabilities.

#### **7.2.EXCLUSION FROM BENEFITS**

The following students are excluded from the benefits envisaged in this Call for application:

- students who are 35 years old as of January 1<sup>st</sup> 2025.
- students enrolling in a study program of the same level as a degree already obtained (those who hold a first-level degree and are enrolling in a single-cycle Master's degree program may request benefits starting from the 4th year)
- who gain recognition or equivalence of an academic qualification obtained abroad, if it's of equivalent or higher value than the one they are enrolling in
- students enrolled in foreign Universities attending the University of Trento as part of international mobility programs
- Students who benefit, for the academic year 2025-2026, from another financial support under the same conditions (economic situation and merit)
- students who are citizens of Non-EU States and who do not reside in Italy, admitted to study programs offered starting from the a.y. 2019-2020, regardless of any changes in residence that occurred after the start of their university studies
- students who do not meet the financial and/or merit requirements set forth herein
- students who enrolled in a study program of the same level as the one in which they are enrolling in for a.y. 2025-2026, except for students who meet all the following requirements:



- who enrolled for the first time in the Italian University System in a bachelor or single-cycle master's degrees program in a.y. 2024-2025
- who have withdrawn from their studies at the end of the first year and intend to enroll for the a.y. 2025-2026 in a course within a different degree class
- who have returned any benefits received for a.y. 2024-2025
- who have paid all debts owed to the University and/or the Student Welfare Institution
- who did not obtain any transfer of <u>credits</u> from previous studies
- students previously enrolled in a study program of the same level,
  except for students who meet all the following requirements:
  - who enrolled for the first time in the Italian University System in a bachelor's or single-cycle master's degree program in a.y. 2019-2020 or in subsequent academic years
  - who have withdrawn from their studies at the end of the first year and enrolled, in the immediately following academic year, in a degree program belonging to a different degree class
  - who have returned any benefits received for the former degree program
  - who have paid all debts owed to the University and/or the Student Welfare Institution
  - who did not obtain any transfer of <u>credits</u> from previous studies
- students who enrolled in a study program of the same level, **except** for students who meet all the following requirements:
  - who enrolled for the first time in the Italian University System in a bachelor's or single-cycle master's degree program in a.y. 2019-2020 or in subsequent academic years
  - who have withdrawn from their studies at the end of the first year and enrolled in the immediately following academic year in a single-cycle master's degree program
  - who did not obtain any transfer of credits from previous studies
  - request benefits starting from the 4<sup>th</sup> year
- students enrolled at the same time in two study programs, who intend to apply for benefits on the second course, having already received the same benefits on the first course
- students enrolled in inter-university programs, whose administrative seat of enrollment is different from the University of Trento
- students enrolled in a first or second level academic diploma course of the "F.A. Bonporti" Conservatory of Music who have already earned a degree issued at the end of a course under the previous Conservatory's system.

#### **7.3.REVOCATION OF BENEFITS**

The scholarship and tuition fees exemption will be revoked for students who are:

- enrolled in the first year and do not gain at least 20 <u>credits</u> (12 <u>credits</u> for the part-time Business Management program) by August 5<sup>th</sup> 2026 or who transfer to another university or withdraw from their studies without having earned the same merit; If transferring from the University of Trento to another university, students may obtain authorization only after returning the benefits provided;
- enrolled in the first year of PhD programs who withdraw from their studies during the first year or do not enroll in the second year
- enrolled in years following the first year who withdraw from their studies by March 31<sup>th</sup> 2026.

#### NOTE

To meet the merit requirement for maintaining the 50% scholarship amount, it will not be possible to use the bonus credits  $^{G}$ .

In case of scholarship revocation, the amount received must be returned to Opera Universitaria **by December 31**<sup>st</sup> **2026**, according to the procedures that will be notified by Opera Universitaria (a notice containing payment instructions will be sent via email). Failure to return such amount by the set deadline will cause the charging of a late payment penalty of  $\in$  50,00 and the payment of the due amount plus interest and expenses, which will be collected according to ordinary enforcement procedures (debt recovery through Trentino Riscossioni).

## The revocation of the scholarship benefit also entails the payment of <u>tuition fees</u>.

For information regarding the payment of tuition fees in case of scholarship revocation, students of the University of Trento can find details at the following <u>page</u>, while students attending the Conservatory of Music can contact their own secretariat.

The benefit of <u>accommodation</u> will be revoked in the cases specified in the Regulation governing the use of Opera Universitaria accommodation facilities, which can be found on the website <u>www.operauni.tn.it</u> in the "<u>Alloggi</u>" section.

For students with disabilities, please refer to point 8.



## 8. INFORMATION FOR STUDENTS WITH DISABILITIES

Without prejudice to the provisions set forth herein, the following is specified.

Students with disabilities, as identified pursuant to article 3, paragraph 1, of Law no. 104 of February 5<sup>th</sup> 1992 or with a disability equal to or greater than 66%, are entitled to total exemption from <u>tuition fees</u> and from <u>provincial student welfare tax</u> for the entire course of study, regardless of their <u>household</u> financial situation. Students have to apply for this benefit upon registration or enrollment at the University.

The duration of scholarships and accommodation benefits for students with disabilities equal to or greater than 66% or with disabilities identified pursuant to Article 3 (1) of Law No. 104 dated February 5<sup>th</sup> 1992, will be as follows:

- nine semesters for bachelor's degree programmes
- seven semesters for master's degree programmes
- thirteen semesters for single-cycle master's degrees programmes in Law and Building Engineering-Architecture
- fifteen semesters for the single-cycle master's degree programmes in Medicine and Surgery

starting from the year of first enrollment.

The amount of the scholarship can be increased up to a maximum of 40% based on the student's disability to allow the use of prostheses and other supports, and all other measures aimed at facilitating access to educational activities and studying.

All students with disabilities, identified in accordance with Article 3, Paragraph 1 of Law No. 104 of February 5<sup>th</sup> 1992, or with a disability of 66% or more, will be subject to merit requirements reduced by 40%. A merit requirement of 84 <u>credits</u> will be required to obtain benefits for the seventh semester in bachelor's degree programs. For the last semester, students will be required to register at least an additional 6 <u>credits</u> above the merit requirement for the previous semester (in addition to any educational obligations stipulated upon admission to the courses).

The University Inclusion Service ("Servizio Inclusione Comunità studentesca") is available for online scholarship application assistance and for any requests regarding specific services and equipment.

Students with disabilities residing in a "non-resident" or "commuter" municipality (as identified in <u>Tables 3</u> and <u>4</u>, in the Appendix) and meeting the economic and merit requirements will be guaranteed an accommodation place at a reduced rate. Students with disability will be provided with accommodation without architectural barriers, designed for their specific needs, within the limits of its availability. These needs must be notified to Opera Universitaria when filling out the online Call for Application form. Without specific indications the room will be assigned automatically.



Students with disabilities who do not meet the economic eligibility requirements specified in the Call but are interested in requesting accommodation can find the information in the Accommodation section on the Opera Universitaria website <a href="https://www.operauni.tn.it/alloggi">www.operauni.tn.it/alloggi</a>.

The University Inclusion Service ("Servizio Inclusione Comunità studentesca"), located at Via Tommaso Gar 16/2, is open from Monday to Friday by appointment only (telephone 0461/282128 – e-mail: inclusione.studente@unitn.it).

## 9. CERTIFICATION OF FINANCIAL CONDITION

In order to submit the application for benefits, students need the Attestazione ISEE per prestazioni agevolate per il diritto allo studio universitario <sup>G</sup> 2025 (in the cases specified in section 9.1) or the ISEE parificato 2025(in the cases specified in section 9.2). The ISPE value will be calculated by Opera Universitaria based on the data provided by INPS.

The limit values to access the benefits referred to in point 2 are:

**<u>ISEE</u>** university students benefits € 26.000,00,

**<u>ISPE</u> € 52.000,00**.

#### 9.1. STUDENTS WHOSE HOUSEHOLD IS IN ITALY

**Before submitting the application for benefits**, students must submit the <u>Dichiarazione Sostitutiva Unica</u> (DSU), which contains information about the <u>household</u> and the income and assets of each household member, directly on the INPS website (www.inps.it) or by contacting a Tax Support Centre (CAF) or other authorized entity. This is fundamental for requesting the <u>Attestazione ISEE</u>.

The scholarships disbursed in the calendar year 2023 must be declared when requesting the ISEE.

Obtaining the <u>Attestazione ISEE per il diritto allo studio universitario</u> takes about 10 working days from submission of the <u>Dichiarazione</u> <u>Sostitutiva Unica</u> (DSU). Therefore, students are recommended to request the <u>Attestazione ISEE</u> well ahead of the deadline to complete the application for benefits within the deadlines set out in <u>point 10.2</u>.



#### NOTE

Only <u>Attestazione ISEE</u><sup>G</sup> for the year 2025 (requested from January 2025) will be accepted, and they must include the following statement: "si applica alle PRESTAZIONI AGEVOLATE PER IL DIRITTO ALLO STUDIO UNIVERSITARIO" followed by the tax code of the student applying for the benefits.

Attestazioni ISEE <sup>G</sup> that are not applicable to subsidized benefits for the right to university education, or that are requested after the application deadline for benefits referred to in <u>point 10.2</u>, will not be considered.

In the case of two or more students belonging to the same <u>household</u><sup>G</sup>, for the purposes of validating the benefits applications, the l'<u>Attestazione ISEE <sup>G</sup></u> must include the statement "si applica alle prestazioni agevolate per il diritto allo studio universitario" followed by the tax codes of all applicants.

If a student makes changes to their <u>Dichiarazione Sostitutiva Unica</u> it must be immediately notified to Opera Universitaria.

Students are required to check whether their <u>Attestazione ISEE</u> contains any note of omissions/discrepancies and is therefore <u>not compliant</u>. In this case, a new <u>DSU</u>, must be submitted no later than October 15<sup>th</sup> 2025. This new DSU must include the information previously omitted or otherwise stated, and Opera Universitaria must be proptily informed.

If the student has requested the <u>ISEE corrente</u>, this need to be valid on tha date of apllication submission.

#### 9.2.STUDENTS WHOSE HOUSEHOLD IS ABROAD

Students whose <u>household</u> is abroad must submit the documentation described in the following paragraphs to the **CAF affiliated with the University of Trento**, within the deadline specified in <u>point 10.2</u>, in order to gainth <u>isee parificato</u>. To book an appointment, students must fill in the relative procedure according to the modalities indicated on the web page <u>Tasse Universitarie</u> of the University website. After obtaining the <u>isee parificato</u>, they will need to send a copy of the <u>Attestazione ISEE parificato</u> to the e-mail address <u>operauniversitaria@pec.operauni.tn.it</u> and then complete the online application

#### 9.2.1.STUDENTS WITH FAMILY UNIT IN AN EU COUNTRY

Students whose <u>household</u> is in an EU country must submit the following documentation regarding their household financial condition, translated into Italian: family status and residence certificate; for all <u>household<sup>G</sup></u> members, income for the year 2023, floor area (square meters) of their main dwelling and other properties and bank deposits in 2023.



#### 9.2.2.STUDENTS RESIDING IN ITALY WITH FAMILY UNIT IN A NON-EU COUNTRY

Students residing in Italy whose <u>household</u> is in a non-European Union country, must submit the following documentation about their family financial condition:

- for students from Particularly poor countries, their financial condition will be assessed based on a certificate issued by the Italian diplomatic authorities in their country of origin. This certificate must confirm that the student does not belong to a household known to have a high income and a high social standing. This certificate can also be issued by the Italian bodies authorized to issue financial guarantees in compliance with relevant legal provisions concerning the enrollment of foreign students at Italian universities.
- students from other non-EU countries, certificate issued by the relevant authorities in their country of origin translated into Italian and authenticated by the Italian diplomatic authority having jurisdiction (Embassy or Consulate) certifying compliance with the original and documenting the <u>household</u> composition and residence, for all <u>household</u> members income for the year 2023, the floor area (square meters) of their main dwelling and other properties and bank deposits in 2023. For those countries where particular difficulties are encountered in obtaining certificates from a local Italian Embassy, the documents in question can be issued by the foreign competent diplomatic or consular representatives in Italy and legalised by a Prefecture.

All students with their <u>household</u> abroad are still obliged to declare any income and assets held in Italy by their <u>household</u>.

The financial condition of stateless students and of students who have obtained recognition of their "international protection" status (political refugees) shall be assessed by only considering the income and assets they may possess in Italy.

## **10. SUBMITTING THE APPLICATION FOR BENEFITS**

#### **10.1.HOW TO FILL IN THE APPLICATION**

The application for benefits must be submitted exclusively online from the Opera Universitaria website <u>www.operauni.tn.it</u> within the deadlines specified in <u>point 10.2</u>, by clicking on '<u>ONLINE</u> <u>APPLICATION</u>' and following all instructions.

To access the electronic procedure, students at the University of Trento can use the SPID code, the Electronic Identity Card CIE or credentials issued by the University. For students of other



Institutes, the SPID code or the Electronic Identity Card CIE are required to access the procedure.

#### NOTE

In the 'Economic Condition' section of the ONLINE APPLICATION, the most recent valid <u>Attestazione ISEE <sup>G</sup></u> 2025 must be selected by clicking the 'Select' button.

When the deadlines set out in <u>point 10.2</u>, are approaching, if the student has not yet obtained the '<u>Attestazione ISEE per prestazioni</u> agevolate per il diritto allo studio universitario, they may enter the reference number of the <u>Dichiarazione Sostitutiva Unica</u> (e.g. CAF000XX-PG0000-2025-N0000000) in the online application. Opera Universitaria will then receive the 'Attestazione' by querying the ISEE information system or, if these's a hindrance, by requesting it from the declarant.

In order to grant a "non-resident" scholarship, the <u>rental</u> <u>agreement</u> referred under <u>point 4.1.3</u>, must be uploaded during the online procedure, in PDF format, **starting from September 9<sup>th</sup> 2025, and no later than October 15<sup>th</sup> 2025.** 

#### NOTE

Only applications fully completed in every required part of the online procedure and DEFINITIVELY SUBMITTED by the deadlines indicated in **point 10.2** will be accepted. If the application is submitted correctly, a receipt will be issued and sent to the provided e-mail address. This receipt must be kept as proof of the application submission.

Any technical issues preventing the online submission of the application must be promptly reported to the Opera Universitaria help desk via e-mail <u>operauniversitaria@pec.operauni.tn.it</u>, always indicating the student's surname, name and tax code, in addition to the reported error/malfunction, within the deadlines specified in <u>point 10.2</u>. Reports sent after the deadline will not be considered.

#### **10.2.WHEN TO SUBMIT THE APPLICATION**

Students can submit their online application as of **July 7<sup>th</sup> 2025**, within the following deadlines:

- by August 5<sup>th</sup> 2025 if the applicant also intends to confirm the accommodation currently in use
- by August 20<sup>th</sup> 2025 if the applicant is also applying for new accommodation assignments
- **by September 8<sup>th</sup> 2025** if only applying for scholarship and tuition fees exemption.



 Students enrolled in PhD courses may apply for the scholarship, exemption from provincial student welfare tax and accomodation from July 7<sup>th</sup> 2025 to November 28<sup>th</sup> 2025.

The application for benefits must be submitted irrespectively of actual enrollment in the a.y. 2025-2026.Different enrollment deadlines may be set after the application submission deadline, even if the student doesn't know the admission test results or hasn't yet enrolled in the course for which they are submitting the application (for example, a student not yet enrolled in a Master's degree program on September 8<sup>th</sup> 2025 must still submit the application for benefits within the deadlines set out in <u>point 10.2</u>).

## SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

For those who enroll in the "filter semester" at another university and matriculate in Trento in the second semester, different deadlines may be established in light of the implementing decrees to be adopted by the Ministry. In this regard, an addendum to the Call for Applications will likely be approved by the end of July, and will be appropriately publicized on the institution's website.

#### NOTE

In the case of 'Attestazioni G' containing omissions or discrepancies, a new DSU G, must be submitted promptly, no later than October 15<sup>th</sup>, 2025, this new DSU must include the previously omitted or incorrectly reported information, with timely notification given to Opera Universitaria.

#### NOTE

For the purpose of awarding the "non-local" scholarship, rental contracts submitted after the October 15<sup>th</sup> 2025 deadline, will not be considered under any circumstances. Students residing in "non-local" municipalities who do not upload their <u>rental agreement <sup>G</sup></u> by the deadline will be considered "commuting students".

## **11. APPROVAL OF RANKINGS AND APPEALS**

Opera Universitaria will approve the accommodation rankings within the first week of September 2025. The scholarship ranking will be approved by October 31<sup>st</sup> 2025. The ranking of scholarships and accommodation for students enrolled in PhD courses will be approved by December 31<sup>st</sup> 2025. The outcome of the submitted application can be checked by accessing the <u>ONLINE APPLICATION</u> on the <u>www.operauni.tn.it</u> website and clicking on



"Application outcome": students from the University of Trento must use the SPID code, the Electronic Identity Card CIE or credentials issued by the University; for students of other Institutes, the SPID code or the Electronic Identity Card CIE are required to access the procedure.

Opera Universitaria will assign scholarships to eligible students depending on available financial resources.

The University of Trento will notify the terms and deadlines for paying tuition fees to students not deemed eligible for scholarship.

An administrative appeal against the measure approving the ranking list is admissible within 30 days to Opera Universitaria, as provided for by art. 4 c. 1 lett. g) of the Regulation on the "functions of the Board of Directors and administrative management of the Director", in compliance with the provisions of Presidential Decree no. 1199 of November 24<sup>th</sup> 1971 ("Simplification of procedures concerning administrative appeals"), the subject line of the communication must indicate: "Ricorso".

The appeal, accompanied by the appellant's identity document, must contain the grounds, any supporting documents, all the appellant's identifying information, date and signature.

Opera Universitaria's offices are available to carry out a preliminary and informal assessment of the appeal's admissibility. In that case, contact Opera by opening a ticket at <u>https://www.operauni.tn.it/en/contacts-us</u> and explaining the issue, without further formalities.

## **12. REPORTING OBLIGATIONS**

Should any changes occur in the data provided after submitting the application, the student must promptly notify Sportello Opera Universitaria (Opera Universitaria Help Desk), particularly in the following circumstances:

- transfer to another degree program
- transfer to another University
- withdrawal from studies
- changes in the information provided in the scholarship application (residence, bank details, financial condition, etc.)
- award of another scholarship or other financial aid
- recognition of exams during the year (and consequent recalculation of benefits granted, considering the <u>year of first enrolment</u>)
- earning of the degree
- amendment to the **<u>rental agreement</u>**
- participation in international mobility programs (for students who reside in "non-local" municipalities, as identified in <u>Tables 3</u> and <u>4</u> in the <u>Appendix</u>).



## **13. OTHER INITIATIVES**

#### **ERASMUS+ PROGRAMME – MUSIC CONSERVATORY**

Conservatory students who, for the a.y. 2025-2026, have been granted both a Erasmus+ scholarship study program (not awarded based on economic condition) and the Opera Universitaria scholarship, may receive additional financial aid of € 200,00 per month during the period of their stay abroad (not including any months of extension), up to a maximum of 10 months and subject to available resources. The amount to which the student is entitled is calculated daily. To obtain financial support, the student must satisfy both the requirements set out in this call and those required by the Erasmus+ program. Opera Universitaria will disburse the grant on the notice received from the Conservatory.

#### SUBSIDY OR OTHER EXTRAORDINARY INTERVENTION

In cases of entirely exceptional and unforeseen situations of serious financial hardship occurring after the time limit envisaged for standard student funding, and in any case taking into account the guiding principles of this Call for Applications, or of documented objective circumstances preventing the merit requirements from being fulfilled, Opera Universitaria reserves the right intervene in by granting special extraordinary grants, an extension of the time limit for fulfilling the required merit, or the allocation of accommodation at a reduced rate. The commission may assess special situations arising from a student's transfer from another university or grant the scholarship to students already holding a threeyear degree in Italy who intend to enroll in a single-cycle degree course or a degree obtained abroad, taking into account the reference principles of this notice and the maximum duration of the benefits envisaged.

The special grant should not be considered an alternative to the scholarship if the relevant requirements have not been satisfied, or the deadline for submitting the ordinary application has not been met.

The extraordinary intervention is of an exceptional nature and can therefore be requested only once during the course of study (for those enrolled in single-cycle master's degree programs, it can be requested twice, provided the events are different and of particular severity).

The student must adequately document their condition of need and send the request to the certified email address

<u>operauniversitaria@pec.operauni.tn.it</u> by the deadlines specified in <u>point</u> <u>10.2</u> of the call. In case of serious health reasons documented by certification issued abroad, this documentation must be provided according to the procedures specified in documentation <u>point 9.2</u> of the call.

The application for subsidy or other extraordinary intervention will be assessed by a panel composed of members of the Board of Directors.



#### **INTERNSHIP ABROAD**

Recipients of Opera Universitaria scholarships who carry out an internship abroad in a country of which they are not citizens may receive an additional monthly allowance of  $\in$  600,00, for a period of up to 4 months, provided they are not recipients of the allowance assigned by the University of Trento under the call for applications for internships abroad or another scholarship or remuneration granted for the same project.

For students in a Master's degree or single-cycle Master's degree programs who are enrolled in their first year beyond the standard duration of the study program – with reference to the <u>year of first enrollment</u>– the allowance will be calculated only for the internship period completed by March  $31^{st} 2026$ .

Opera Universitaria will disburse the benefit at the end of the completed internship, based on communication from the University of Trento.

## **14. ACCURACY OF DECLARATIONS**

Opera Universitaria verifies the accuracy of the statements made by students as of the expiration date for submission of the applications and also after delivery of the benefits, pursuant to article 71 of Presidential Decree no. 445/2000, article 10 of Legislative Decree no. 68/2012 and article 11 of Prime Ministerial Decree 159/2013 and in conformity with the resolution of the Board of Directors of Opera no. 29 of November 8<sup>th</sup> 2010.

If the content of the statement submitted by the student is found to be inaccurate after verification, the assigned benefits will be revoked and an administrative penalty equal to three times the amount received will be imposed. The student will also lose their right to receive further allowances at any time during their study program.

Opera Universitaria will report the matter to the judicial authority for the possible application of criminal laws for actions constituting an offence. It is therefore advised to exercise the utmost care and rigor when presenting statements.

## **15. PROCESSING OF PERSONAL DATA**

INFORMATION ON THE PROCESSING OF PERSONAL DATA pursuant to Article 13 of EU Regulation 2016/679 on the protection of individuals with regard to the processing of personal data (hereinafter referred to as 'Regulation' or 'EU Regulation').

Opera Universitaria of Trento provides the following information about the processing of your personal data pursuant to Article 13 of European Regulation 2016/679.

#### 1. Purpose and methods of data processing

To implement the aims of Opera Universitaria of Trento, as set forth by Provincial Law no. 9 of May 24<sup>th</sup> 1991 establishing it, and to provide the



services envisaged by said law, your personal data will be collected and processed:

- a. to verify the requirements for access to student welfare benefits according to the criteria set out in this Call for Applications and for any other purpose required by law;
- b. for procedures connected with the assignment of scholarships, <u>accommodation places</u> and related services, exemption from <u>provincial student welfare tax</u> and <u>tuition fees</u> and for the other benefits envisaged by this Call for Applications;
- c. to process statistical reports in aggregate and anonymous form;
- d. Subject to your prior explicit consent, pursuant to article 6.1, (a) of the EU Regulation, for ancillary purposes such as monitoring the quality of services to assess users' satisfaction with the services offered.

In relation to the aforementioned purposes, the processing of data by Opera Universitaria will be carried out in compliance with the principles of lawfulness, fairness and transparency, protecting your privacy and that of your family members, in compliance with the principles set out in Article 5 of EU Regulation. The processing can be performed manually, using printed documents as well as with the aid of electronic or automated means. Data are collected and processed at the Opera Universitaria offices using appropriate document archives/servers. Opera Universitaria shall take all measures to promptly correct any inaccurate data relevant to the processing purposes.

Your personal data is processed using appropriate technical and organizational security measures in accordance with article 32 of the EU Regulation, to guarantee a security level appropriate to the risk, minimizing the risks of destruction or loss, processing that does not comply with the purpose of the collection.

Your personal data is not the subject of any automated decision-making or profiling process.

With reference to the specific data that can reveal your racial or ethnic origin, your state of health or the state of health of your family members, as per article 9 paragraph 1 of the EU Regulation, processing shall be carried out in proportion to the purpose pursued, by also adopting appropriate and specific measures to protect your fundamental rights.

#### 2. Obligation to provide personal data

To achieve the purposes set forth by Provincial Law no. 9 of May 24<sup>th</sup> 1991 establishing Opera Universitaria, the provision of personal data is mandatory. Refusal to provide personal data will make it impossible for Opera Universitaria to pursue the purposes as under 1(a), (b), (c).

While providing the data for the purposes under 1(d) is optional, failure to do so will make it impossible to pursue the purposes stated thereunder.

#### 3. Scope of data circulation and communication

Your personal data will be disclosed to Opera Universitaria employees authorized to process data, or to natural or legal persons who provide consulting services or cooperate with Opera Universitaria for the purpose of providing the student welfare benefits.

Opera Universitaria may need to disclose your personal data to external parties that it trusts or to professional bodies such as public, institutional or professional entities that are authorized by law to request receipt of data, or to third-party companies or professionals who provide services to Opera Universitaria. These entities and companies shall process data as independent data controllers or "data processors" duly appointed based on contractual agreements drawn up in compliance with the provisions of article 28 of the EU regulation.

Data may be disclosed to other public entities, including the Ministry of Finance, the Guardia di Finanza and the State Police, if this is required by law or regulation, or otherwise, if disclosure is necessary for the performance of the institutional functions of such entity.

#### 4. Retention and possible transfer of data

Your personal data will be stored at Opera Universitaria di Trento and will not be transferred to a third country or an international organization. The data you provide shall be kept for the time strictly necessary to ensure access to student welfare benefits and until all legal obligations and/or administrative requirements have been fulfilled. The data may be kept for a longer period if it is necessary for archiving purposes in the public interest, or for scientific, historical research, or statistical purposes. In that case, Opera Universitaria ensures respect for the principle of data minimization as per article 89, paragraph 1 of the Regulation.

#### 5. Data subject's rights

We remind you that you are entitled to:

- obtain information regarding how your data is processed and any other information provided by Article 15 of the Regulation (commonly referred to as the *right of access*)
- obtain the correction of inaccurate personal data concerning you under ex Article 16 of the Regulation (commonly referred to as the right to rectification)
- obtain a restriction on the processing of personal data concerning you under Article 18 of the Regulation (commonly referred to as the *right to restriction of processing*)
- object to the processing of your personal data in the cases and manners provided for by Article 21 of the Regulation (commonly referred to as the *right to object*).

## GLOSSARY

## ACCOMMODATION

The procedures for access to and revocation of accommodation services are set out in the <u>Rules and Regulations governing the Use of Opera</u> <u>Universitaria Accommodation Facilities</u>, which can be found on the website <u>www.operauni.tn.it</u>. These are accepted upon completion of the application for benefits.

## ATTESTAZIONE ISEE PER IL DIRITTO ALLO STUDIO UNIVERSITARIO

Certification attesting the Equivalent Financial Situation Indicator (ISEE) for apply for student welfare benefits, issued following the submission of the Dichiarazione Sostitutiva Unica (DSU) containing the personal details, income and asset data of the student's household.

The attestation is provided by INPS to the declarant within 10 working days of receving the Dichiarazione Sostitutiva Unica and contains the wording "si applica alle PRESTAZIONI AGEVOLATE PER IL DIRITTO ALLO STUDIO UNIVERSITARIO" (THIS DOCUMENT APPLIES TO UNIVERSITY STUDENT BENEFITS), followed by the tax code of the students requesting the benefits.

## CREDITS

Credits are a means of measuring the learning activities, as defined in Legislative Decree no. 509/1999. For each study program, the teaching department in charge at each university assigns a number of credits to the various teaching activities (lectures, practical sessions, internships, seminars, theses, etc.).

## DICHIARAZIONE SOSTITUTIVA UNICA

The Dichiarazione Sostitutiva Unica (DSU), referred to in Prime Ministerial Decree no. 159 December 5<sup>th</sup> 2013, as amended, is a document that contains the personal details, income and asset data of the student's household. This document must be filled out to calculate the ISEE for accessing welfare benefits. The data contained in the DSU are partly self-declared and partly obtained from the Italian Inland Revenue and INPS. For the self-declared sections, the person filling out the DSU (declarant) assumes responsibility, including under criminal law, for the statements made. The DSU is made up of several modules and sections to be filled out according to the household characteristics and the type of benefit requested: for the attestazione ISEE for university student benefits, the DSU must be entirely filled out (DSU "integrale").

The scholarships and compensation for paid student collaborations in the year 2023 must be declared for ISEE purposes.



## ESSE3

Esse3 is the management system used by the University of Trento to record all the events relating to a study program.

## HOUSEHOLD

The student's household is composed of the persons officially recorded as family members at the date of submitting the Dichiarazione Sostitutiva Unica, subject to the provisions of Article 3 of Prime Ministerial Decree No. 159 of December 05<sup>th</sup> 2013.

If parents do not co-habit with the applicant student, the applicant is part of their parents' household, unless they are an orphan of both parents, a "care leaver" or both of the following requirements are satisfied:

- a. the student has resided outside the original family's dwelling for at least two years prior to the date of submitting the Dichiarazione Sostitutiva Unica, living in a housing unit not owned by a household member;
- b. the student's income, as an employed worker or similar worker, declared in their tax return for at least two years is not less than 9.000 euros per year.

For further information please refer to Article 8 of Prime Ministerial Decree No. 159 of December 5<sup>th</sup> 2013.

#### IBAN

The IBAN (International Bank Account Number) is an international code made up as follows:

- 2 letters representing the Nation (IT for Italy)
- 2 control figures
- The national BBAN code.

#### ISEE

ISEE is the Equivalent Financial Situation Indicator, the attestation of which enables access to welfare benefits or utilities under favorable conditions. The ISEE is derived from the ratio of the Financial Situation Indicator (ISE = absolute value given by the sum of income and 20% of movable and immovable assets owned by household members) to the parameter derived



from the equivalence scale shown below, including the established increases.

#### Equivalence scale:

HOUSEHOLD MEMBERS	PARAMETER
1	1,00
2	1,57
3	2,04
4	2,46
5	2,85

The following increases apply:

- 0,35 for each additional member;
- 0,5 for each member with moderate or severe disability or non-self-sufficient;
- 0,2 if the household includes three children, 0.35 in case of four children, 0.5 in case of at least five children;
- 0,2 for households with minor children, raised to 0.3 if there is at least one child under three years of age, and both parents or the sole parent have carried out working or business activities for at least six months in the year of the declared income. The increase also applies to households exclusively made up of only one non-working parent and minor children. For the sole purpose of the increase, the non-cohabiting parent, who is not married to the other parent, who has recognized the children, is part of the household, unless the specific cases referred to in Article 7, paragraph 1 of Prime Ministerial Decree No. 159 of 05 December 2013 apply.

To determine the parameter of the equivalence scale, the household member who benefits from ongoing residential social and health benefits or is a non-relative cohabiting member of the household and is not considered as an independent household, increases the equivalence scale by 1.

The ISEE indicator differs according to the type of benefit requested and is valid from the date of submission of the Dichiarazione Sostitutiva Unica until 31 December. The Certification submitted as of January 2025 refers to the income received in the second calendar year prior to the Dichiarazione Sostitutiva Unica.

For the purpose of calculating the ISEE for university student benefits, specific criteria apply to the definition of household (see "Household" definition).

Scholarships awarded in the year 2023 must be declared for ISEE purposes as tax-exempt income/assistance payments.

Only the amount of the scholarship received in 2023 in relation to the corresponding parameter of the equivalence scale will be subtracted from the ISEE value. Other tax-exempt incomes (e.g. remuneration received for student collaborations, mobility supplement...) will not be deducted from the ISEE value.

## **ISEE CORRENTE**

The ISEE corrente can be requested when, although you already have a valid ordinary ISEE, there is a change in your work situation or an interruption of social security and welfare benefits and allowances that fall outside your total income (as declared for IRPEF purposes) for one or more family members; or, when there is a more than 25% decrease in the overall income capacity of your household. For more details see art. 10 of Legislative Decree no. 147 of September 15<sup>th</sup> 2017, as amended (Article 28-



bis of Decree Law No. 34 of April  $30^{th}$  2019, converted with amendments by Law 58 of June  $28^{th}$  2019).

## **ISEE PARIFICATO**

The ISEE parificato is the indicator of the equivalent financial situation of a student's household residing abroad (Article 8(5) of Prime Minister's Decree No. 159 dated December 5<sup>th</sup> 2013), as identified under the Memorandum of Understanding entered into on June 3<sup>rd</sup> 2015 between the National Association of Bodies for the Right to University Education (ANDISU) and the Tax Support Centres (CAFs) enrolled in the Register of CAFs for employees who are members of the National Council.

## ISPE

ISPE is the Equivalent Asset Indicator that is calculated by dividing the asset indicator (ISP = total real estate assets - deductions and exemptions) + (total movable assets - deductions and exemptions) of the applicant's household by the equivalence scale coefficient (see "ISEE"). ISPE refers to the movable and immovable assets of the second calendar year preceding the submission of the Dichiarazione Sostitutiva Unica.

## NON-COMPLIANT ISEE

Non-compliant ISEE is when INPS identifies any omissions/discrepancies with respect to the party's statements. For more details see article 11, paragraph 5 of Prime Ministerial Decree no. 159 of December 5<sup>th</sup> 2013 and Article 3 of Decree of November 7<sup>th</sup> 2014.

## PARTICULARLY POOR COUNTRIES

As laid down by Ministerial Decree no. 166 of March 2<sup>nd</sup> 2025, the following countries are considered "particularly poor": Afghanistan, Angola, Bangladesh, Benin, Burkina Faso, Burundi, Cambodia, Central African Republic, Chad, Comoros, Democratic People's Republic of Korea, Democratic Republic of the Congo, Djibouti, Eritrea, Ethiopia, Gambia, Guinea, Guinea-Bissau, Haiti, Kiribati, Lao People's Democratic Republic, Lesotho, Liberia, Madagascar, Malawi, Mali, Mauritania, Mozambique, Myanmar, Nepal, Niger, Rwanda, Sao Tome and Principe, Senegal, Sierra Leone, Solomon Islands, Somalia, South Sudan, Sudan, Syrian Arab Republic, Tanzania, Timor-Leste, Togo, Tuvalu, Uganda, Yemen, Zambia.

## **PROVINCIAL STUDENT WELFARE TAX**

The term "provincial student welfare tax" means the tax provided for by Article 3, paragraph 20, of Law no. 549 of December 28<sup>th</sup> 1995 and regulated, for the Autonomous Province of Trento, by Provincial Law no. 1 of January 7<sup>th</sup> 1997. The tax is due from students enrolling in study programs at the University of Trento, as well as at legally recognised universities, university institutes and higher education university institutes, with head office in the province of Trento and that award legally recognised



study qualifications. The amount of the tax for A.Y. 2025/2026 is determined by resolution of the Provincial Government no. 333 of 3 March 2017 and no. 341 of 2 March 2018.

## **RENTAL AGREEMENT**

Rental agreements must be signed and registered with the Italian Inland Revenue in the student's name and be valid for at least 10 months during a.y. 2025-2026 (between September 2025 and August 2026). The copy of the agreement must contain the registration details and be uploaded to the online procedure in PDF format.

If an agreement or a multi-year agreement is renewed, to prove its validity for a.y. 2025-2026 it is necessary to submit either a copy of the F23 tax form (or an electronic receipt) proving payment of the registration tax, or documents proving that the "cedolare secca" option has been chosen. Students who have entered into a multi-year agreement choosing the "cedolare secca" option and who have already delivered it to Opera Universitaria, only need to provide a self-certification during the term of the agreement, stating that they are still the tenant of the same accommodation; for this purpose, the "Contract self-statement" form, available in the <u>Scholarships/Forms</u> section of the website <u>www.operauni.tn.it</u>, must be uploaded to the online application.

## S.T.E.M.

A set of the scientific-technological disciplines that comprises the following courses offered at the University of Trento:

- Bachelor's degree courses in Physics, Computer Science, Industrial Engineering, Computer, Communications and Electronics Engineering, Biomolecular Science and Technology, Mathematics, Civil Engineering, Engineering for the Environment and the Territory;
- single-cycle Master's degrees in Construction Engineering/Architecture;
- Master's degree courses in: Cellular and Molecular Biotechnology, Quantitative and Computational Biology, Physics, Mathematics, Computer Science, Artificial Intelligence Systems, Information and Communications Engineering, Materials Engineering, Mechatronics Engineering, Management and Industrial Systems Engineering, Civil Engineering, Energy Engineering, Engineering for the Environment and the Territory, Environmental Meteorology, Environmental Meteorology and Climate Physics, Data Science, Bioengineering for personalized medicine.

## **TUITION FEES**

Tuition fees for the University of Trento are the fixed-rate university contributions and the variable contributions (ISEE calculated) required to the student who enrolls in a study program. For information on tuitions fees



payable to the Conservatory of Music or to other University Institutes please contact the relevant administrative offices.

## YEAR OF FIRST ENROLMENT

The term "year of first enrolment" means the enrolment, for the first time, in the first year of a study program attended at any University (or Institutes that award academic qualifications), except for students who fulfill the requirements set out in paragraph (a) or (b):

- a. who enrolled for the first time in the Italian University system in an undergraduate or single-cycle Master's degrees program in a.y. 2024-2025; have withdrawn from their studies and intend to enroll for the a.y. 2025-2026 in a course within a different degree class; have returned any benefits received for a.y. 2024-2025 and paid any outstanding amounts due to both the University and the Student Welfare Body;
- b. who enrolled for the first time in the Italian University system in an undergraduate or single-cycle Master's degree program in a.y. 2019-2020 or in subsequent academic years, have withdrawn from their studies at the end of the first year and enrolled for the next academic year in a course within a different degree class (or, in case of foreign students, have transferred to a course within a different degree class, without credit transfer); have returned any benefits received in the previous course and have paid any outstanding amounts due to both the University and the Student Welfare Body.

If the student has benefited from a shorter duration of their studies and therefore from the recognition of previous examinations, the year in which they first enrolled at the University for the first time will be treated as the year of his/her first enrolment.

Any periods of interruption are not taken into consideration when assessing merit if the student has submitted an application for "temporary suspension" of study in specific situations, namely:

a) the birth of a child (for female students); b) serious infirmities. Any academic action carried out during the interruption period will automatically deprive the student of their right to such benefit.
