INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA (pursuant to EU Regulation 2016/679)

Universitary Institution, whose registered office is located in Trento, via della Malpensada n. 82/A, tax code 80003390228 and VAT number 00453340226 (hereinafter referred to as the 'Data Controller'), informs you, pursuant to EU Regulation no. 2016/679 (hereinafter referred to as 'GDPR'), that your data will be used in the following ways and for the following purposes:

A. Subject of the Agreement

The Data Controller processes identifying personal data (name and surname, phone number, address, email, payment details, photo for user profile) and special data (data of minors) – hereinafter referred to as 'personal data' or 'data' – provided by you upon the conclusion of each contract for the services of the Data Controller.

B. Purposes of the agreement

1) Your personal data will be used:







- to manage users' acceses in the gym
- to carry out all activities necessary to achieve the services you wish to use
- to fulfill pre-contractual, contractual, and tax obligations arising from existing relationships with you, in accordance with the provisions of Article 6, letters b), c), d), e) of EU Regulation 2016/679.
- 2) Only with your specific consent (Article 7 GDPR), for the following purposes:
 - to send you via email, mail, and/or SMS and/or phone contacts, newsletters, commercial communications, and/or promotional material regarding products or services offered by the Data Controller, and to assess your satisfaction with the quality of the services;

C. Methods of Processing

The processing of your personal data is carried out through the operations indicated in Article 4, no. 2) GDPR, specifically: collection, recording, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, restriction, communication, deletion, and destruction of data. Your personal data is processed both in paper form and in electronic and/or automated form. The Data Controller will process personal data for the time strictly necessary to fulfill the above purposes.

D. Access to Data

Your data may be made accessible, for the purposes mentioned in point B, to employees and collaborators of the Data Controller, in their capacity as data processors and/or system administrators.

E. Communication of Data

Without the need for explicit consent – see Article 6, letters b) and c) GDPR – the Data Controller may communicate your data for the purposes of point B.1 to supervisory bodies, judicial authorities, insurance companies for the provision of insurance services, as well as to all subjects to whom communication is mandatory by law for the fulfillment of the aforementioned purposes. These subjects will process the data as autonomous data controllers. Your data will not be disseminated.

F. Data Transfer

Personal data is stored on servers located in Trento (Italy), within the European Union. It is understood that the Data Controller, where necessary, has the right to move the servers outside the EU. In such cases, the Data Controller ensures that the transfer of data outside the EU will be in compliance with applicable legal provisions, subject to the signing of the standard contractual clauses provided by the European Commission.

G. Nature of Data Provision and Consequences of Refusal to Respond

The provision of data for the purposes mentioned in point B.1 is mandatory. In their absence, we will not be able to guarantee the services in point B.1. The provision of data for the purposes mentioned in point B.2 is optional. You may choose not to provide any data or to later deny consent for the processing of previously provided data: in this case, you will not receive newsletters, commercial communications, or promotional materials related to the services offered by the Data Controller. You will still have the right to the services mentioned in point B.1.

You have the rights of access as outlined in Articles 15-21 GDPR, including the right of access, right to rectification, right to erasure ("right to be forgotten"), right to restriction of processing, right to data portability, right to object, as well as the right to lodge a complaint with the Supervisory Authority.
